## VI. Legislative Overview – West Majors

- Budget ensuring GOveners goals increasing fee for 911 (6 cents for 988)
- Annual grant program reauthorization in June 2024
- Fire Relief will rely on suggestions from this board
- Commissioners Confirmation will soon be scheduled

  - OSFC needs to share list of Fire Departments with board members
- VIII. Update on Emergency Reporting Software (PENNFIRS) We have put a hold on the process. ESO to extend emergency reporting contract an additional 6 months There has NOT been a vendor selection at this date.
  - Specification is that the product be compatible
  - End User Friendly OSFC working directly with other state agencies (VDMU).
  - How consistent is the reporting from fire departments it is not consistent. Share the monthly report number of incidents with the board members
  - Meeting is needed with federal partners and report back to board
- **IX.** Discussion of eligible projects for the Relief Association Funds
  - Act 91 require OSFC certify \_\_\_\_\_ to receive the funds. Aud Gen to collect the info and forward to OSFC for Certification
  - Renovations of facilities
    - Building owned by Municipality with agreement for the fire department to used facility
    - Commissioner: If a piece of fire apparatus is housed in the facility it is allowable.
    - Key question no definition in the act for a "Facility"
    - Concern about restricting from using funds for banquet hall, bar, etc.
    - Suggestion provide for a certain percentage of the funds to go to facility
    - Should be directed related to safety and well being of the firefighter
    - Look at the definition in the loan program for facility.
    - Commissioner will provide a policy statement then look at recommendations.
  - Cancer Screening for Members of the Department
    - Fall under section 11 –
    - Pay for medical bills for Cancer
    - Senator Muth: Cover Cancer
    - Current legislation does not talk about illness.
    - Distress circumstances
    - Cover interim period while waiting for insurance to act.
    - Cancer insurance should be an allowable expense.
    - OSFC will create policy statement and send it to the board for recommendations

- X. Update on Sub-Committee for Relief Association Reform.
  - Bruce Trego has stepped down as chair of the subcommittee and Steve Bair has taken his place
  - Subcommittee members: Bruce Trego
  - Required to give legislature a report by November of this year.
  - Give financial assistance for suplimental insurance.
  - Will be reaching out to find how much insurance is being carried
  - Combination departments are growing important that not only portions of the fire department(s) benefit from Relief funds.
  - Reallocation instead of 9% it should be closer to 25%
  - Should be a bottom line amount anything over that would be allocated.
  - Concern should be requirements to received funds. Do reporting, etc
  - Question: have you considered incentives for consolidating.
  - What is a combination fire department: has paid personnel to supplement the volunteers. There are either Municipal fire departments or volunteer fire departments.
  - Municipality and fire department working together. It should be sufficient to be demonstrated that the funds are being used to assist the community.
  - Some departments have significant funds saved in relief fund should there be a cap.
