Relief Reform Working Group Report to State Fire Advisory Board September 5, 2023

Working Group Members: Bruce Trego, Tom O'Donnell, Frank Zangari, Sam Aungst, and Steve Bair (Chair)

The most recent meeting of the Working Group was August 23<sup>rd</sup>. Additionally, Working Group members hosted or attended Advisory Board Regional Meetings in August and September. The Chair of the Working Group has attended 5 regional meetings, with plans to attend 2 remaining meetings scheduled after this date.

Based on average attendance numbers for regional meetings, at least 200 people have had the opportunity to consider the recommendations of the Working Group and ask questions related to the proposed framework. The Pennsylvania Fire and Emergency Institute set up an on-line data collection site for people to comment on the proposed framework and as of August 31, sixty-four responses have been received. Links to the data collection site appear on both the PFESI and OSFC home pages.

Of the 64 comments received, 49 expressed support or nonsupport and/or offered specific suggestions. The remaining responses were simply requests for clarification or what can best be described as 'rants'. The on-line data shows 48% of the respondents offering unqualified support for the framework and a total of 94% generally supporting the framework. Approximately 6% of the respondents do not support the framework and prefer to leave the system 'as is'. These numbers are consistent with the 2021 surveys where 90% of the respondents supported relief reform and 10% opposed relief reform.

The Working Group believes it unlikely that additional data, significant enough to change the proposed framework, will be received. In order to submit a formal report by year-end to the Legislature as required by Act 91 of 2020 (§ 7419.1) the Working Group suggests a motion for formal acceptance of the current framework offered by the Working Group. Once adopted, the Working Group will write a formal report for consideration and adoption at the State Fire Advisory Board scheduled for November 16. This will enable the Board to meet its obligation.
