2023 – 24 FCEMS GRANT PROGRAM IMPORTANT DATES

October 20, 2003 – To be eligible for the increased merger funding available with this grant, fire companies or EMS services must have merged their use of equipment, personnel, and services on or after October 20, 2003. **Organizations that merged prior to October 20, 2003**, <u>will not be eligible for the increased funding</u>.

July 1, 2023- Eligible projects initiated and paid for between July 1, 2023 – September 1, 2024 will be considered as eligible projects for the 2023-24 grant year.

July 1, 2023 – To qualify for the Certification Bonus Points, an individual must have been certified at a minimum level of Fire Fighter 1 on or before July 1, 2023, by the National Professional Qualifications Board or by the International Fire Service Accreditation Congress and verified by the Pennsylvania State Fire Academy.

July 31, 2023 – PennFIRS incidents for FIRE and RESCUE companies must be reported through 7/31/23 to be considered current and eligible to apply for the 2023-24 FCEMSGP grant.

July 31, 2023 - Deadline for transmission of 2022-23 FCEMS Grant Agreements for award disbursement.

August 1, 2023 – Deadline for submitting merger paperwork to apply as a merged company for the 2023-24 grant.

September 6, 2023 - The 2023-24 FCEMS Grant application opens at 4:00pm.

October 20, 2023 – The 2023-24 FCEMS Grant application closes at 4:00 p.m.

December 21, 2023 - The Office of the State Fire Commissioner must approve or disapprove applications within 60 days of the application submission deadline. Applications received by the OSFC, which have not been approved or disapproved by December 21, 2023 will be considered as approved, subject to the provisions of Act 91 of 2020, as amended (which includes the requirement to submit a final report for each grant received).

January 2024 - The 2023-24 FCEMS Grant Agreements will be available mid to late January 2024.

July 1, 2024 -Deadline for submission of 2023-24 FCEMS Grant Agreements.

July 31, 2024 - Deadline for transmission of 2023-24 FCEMS Grant Agreements for award disbursement.

August 1, 2024 – Deadline for submitting merger paperwork to apply as a merged company for the 2024-25 grant.

August 12, 2024 - Last day project modifications can be submitted for the 2023-24 grant is 4:00pm on August 12, 2024.

September 1, 2024 – The deadline for submitting your electronic Final Report for the 2023-24 Grant is 4:00pm on September 1, 2024.

November 1, 2024 – 2023-24 hard copy final report documents <u>for audited companies</u> must be received via email <u>ra-vfcvasgp@pa.gov</u> by **11/1/2024**.
